#### **PURPOSE:**

To approve the purchase of Chromebooks.

#### **EXPLANATION:**

The current Dell Chromebook 3180s and Samsung 3s are no longer able to receive critical updates. This will cause issues with standardized testing and will not provide necessary security vulnerability patches. It is recommended that 750 Chromebooks be replaced for the 1:1 student program at Springbrook Middle School for the upcoming school year.

The current REMC Spot Purchasing Program rate is \$237,585 for both devices and licensing. The District will source the purchase at the lowest possible rate if there is another vendor that can provide this quantity at a lower price. Per board policy 3301 Purchasing and Procurement, the District is able to use cooperative purchasing.

The Assistant Superintendent of Curriculum and Instruction has received permission to use ESSER grant funds to cover part of the purchase. These grant funds will be used in addition to the capital project and technology funds and/or bond funds.

#### **RECOMMENDATION:**

It is the recommendation of the Assistant Superintendent for Administrative Services that the Adrian Board of Education approve the purchase of Chromebooks in an amount not to exceed \$237,585.

#### **PURPOSE:**

To approve the course offerings for all District K-12 schools.

#### **EXPLANATION:**

The course listings (elementary) and course books (secondary) represent the academic offerings at Alexander Elementary, Lincoln Elementary, Michener, Elementary, Prairie Elementary, Springbrook Middle School, High School, and Adrian Community High School.
